**1/2025** To receive reports from County & District Councillors, if present – Cllr Bunney gave an update on matters of interest within West Lindsey. Changes to the council make up at District and County is imminent. County Council elections are still scheduled for May. Work is continuing around Scampton following the withdrawal of government requirements. Roads – funds forthcoming from central government for pot holes. Some funds earmarked for this area but focus will be on high priority routes. Funding for WLDC core functions has been frozen this year. Costs for Green bin likely to rise. Waste food bins are likely to come into effect in 2026. Flooding issue on Front Street is still on the list to be addressed. Private Lane has been acknowledged as responsibility of Highways but due to the grade of the road it will only be stoned – not surfaced.
